The **Art Local** grant program is a business & building improvement program where **downtown businesses and/or building owners can apply for matching funds toward interior or exterior public art projects, in partnership with local artists.** **The 2022 Art Local Grant encourages downtown business and building owners to apply for matching funds of up to \$1,500, or 50% of a project.** This program is administered by Marietta Main Street in alignment with our mission to promote, preserve, and enhance downtown Marietta according to the Main Street Approach. All project applications will be reviewed by a diverse jury as appointed by the Marietta Main Street Board of Directors. Funding is not guaranteed for any applicant.

The vision of **Art Local** is a vibrant, revitalized, visually appealing downtown that celebrates local artists and enhances the creative economy in the City of Marietta. This program is intended to pair financial resources with downtown business and/or building owners who seek to partner with local artists to install public art.

### ELIGIBLE APPLICANTS

- Commercial business/building owners
- Projects within the C4 District of the City of Marietta, OH
- New projects, not completed, under construction, or underway
- Projects with 50% matching funds from other funding sources

### ELIGIBLE PROJECTS

- Interior and exterior public art projects, such as murals, sculptures, memorials, integrated architectural or landscape architectural work, or community art
- Projects that partner with local artists; local is defined as a 90-mile radius
- Projects that increase the value of a building, business, and/or the creative economy downtown
- Projects that can be funded and completed in full no later than **November 1, 2022**, including final project reporting requirements

Ineligible projects for Art Local are government properties or national franchise properties. Project funding will not be awarded for proposals that do not partner with local artists, for commercial signage or advertisements of a building and/or business, or incomplete applications.

### Reporting and Records Retention

The grantee will submit a final status report which will include a narrative and financial expenditure as well as photographic evidence of before and after work. Funded projects will be expected to **maintain supporting financial documentation of grant expenditures for three years** beyond the close of the grant.

### Financial Reimbursement Procedures

Funded projects will be provided with the necessary paperwork for reimbursement and reporting requirements. Funds are reimbursed by submitting paperwork and reporting requirements to Marietta Main Street.

- Upon 50% of the work being completed, the grantee may request 50% of the funding
- The remaining 50% will be awarded upon completion of the project once proper financial and photographic documentation, has been submitted.

- All applications must be submitted in full no later than **May 20, 2022**. Awardees will be announced by **June 3, 2022**.
- All projects must be completed and final reimbursement materials submitted by **November 1, 2022**.
